# CC Police Seeking Suspect in Fox Hills Armed Robbery

Culver City police are looking for suspect in connection with an armed robbery outside a Japanese restaurant in Fox Hills. On February 14, at, 8:38 p.m., Culver City Police Department received a call about an armed robbery that occurred

near California Roll and Sushi, 6251 Bristol Parkway.

According to a police report, the victim was sitting outside of the business with his wife when two men approached them. One man pulled out a black handgun, pointed it at both victims and demanded their property.

"In fear for their life," police said, "one of the victims handed the suspect his personal property." Both men then ran away and entered a waiting light-colored SUV. The vehicle then sped northbound through the parking lot and then westbound on Green Valley Circle, police said.

The suspects are described as follows: male black, 20 years old, thin build, wearing dark clothing; male black, 20 years old, thin build, wearing a gray hoodie.

Culver City's unmanned aerial vehicle (UAV) or drone pilot program is off to a flying start.

In the past 22 months, the Culver City Police and Fire Departments have used drones 50 times in perimeter searches for felony suspects, fires and crime scene operations, among other uses, according to police officials. The use of drones with high-powered cameras is becoming common place for police and fire agencies across the county.

At its recent meeting, the Culver City Council discussed a report on the UAV pilot program, which has cost \$107,000 so far, and approveda staff request for \$13,000 to continue its operation for the next 14 months.

Most councilmembers were

supportive of the program and the "evidentiary value of drone footage" but some wanted staff to provide more "detailed data on drone usage for more transparency."

Proposed and formed in 2019, the drone program assist first responders address rapidly unfolding emergency incidents. It was instrumental in the arrest of 20 suspects, city officials said.

The drones were used 24 times for perimeter search for armed and/or felony suspects, 6 times for crime scene operation (including shooting and traffic accidents), 4 times for fires, one time for disaster management (bomb threat) and 15 times for support search/arrest warrant operation, according to police officials.

The city currently has 8

drones – which cost \$85,687 – and16drone pilots on staff, all of whom are licensed through the FAA.

"Although we often have pilots on duty when a UAV is needed, there are times when a pilot is called in from home on overtime or held over their regular work hours on overtime for emergency incidents," the report said. The total overtime cost for the 22-month pilot program was \$33,075.

The program, including the drones, pilot training and pilot overtime, will cost \$120,266 through next year, city officials said.

# Covid-19 Cases, Deaths Declining in Los Angeles County, Culver City

Experiencing the same decline in the rate of infection as Los Angeles County, Culver City recorded 92 new cases of coronavirus and 6 deaths in the past two weeks, the County Health Department has announced.

As of press time yesterday, the number of local residents with Covid-19 rose to 2029 cases, representing only a 4% increase in the past 2 weeks. Deaths related to coronavirus inched up to 77 in Culver City. More than half of the deaths occurred in nursing homes and assisted living facilities.

County-wide, the total infected now stands at 1,174,340with 19,514deaths. More than 90% of people who died had underlying health conditions. On Thursday, Public Health Department reported 2,873 new cases of Covid-19 and 153 deaths.

Health officials said the 7-day average of daily cases continues to decline in the county; as of February 9, Covid-19 cases declined by 85% to an average of 2,230 cases per day. Also declining is the average of daily deaths. This number peaked at 229 on

January 10, and declined to an average of 91 deaths per day on February 9, representing a 91% decrease.


There are 2,757 people with Covid-19 currently hospitalized and 31% of them are in the ICU. The total represents a 60% decrease from January 8 when hospitalizations peaked above 8,000. The positivity rate has also fallen from 15% in December to 5% yesterday.

"While we share cautious optimism with others, we remain concerned that actions over Super Bowl weekend could lead to another increase in cases starting next week if individuals were not taking precautions," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "Each individual and business doing their part to contribute to this decline continues to be the key to reducing transmission in L.A. County."

Nearly 1,541,000 doses of COVID-19 vaccine have been administered across the county, Public Health said. Of those vaccinated, 399,642 people have received second doses. This means 5.1% of the County's population of 16 and older

have now been fully vaccinated.

Public Health also announced it is opening up eligibility for the vaccine to three additional sectors starting on March 1: education and child-



care, food and agriculture, and first responders and law enforcement. The county is working with partners to address challenges in vaccinating the more than 1.8 million workers that will be eligible for vaccine, officials said.

Covid-19 vaccine supply remains very limited, Public Health said. For information about vaccine appointments in L.A. County, when your turn is coming up, to sign up for a vaccination newsletter, and much more, visit: www.VaccinateLACounty.com.

# Fatal Car Crash at Olympic & Overland

A woman was killed and a teenager was hospitalized in a West Los Angeles car crash Wednesday, an LAFD spokesman said

Witnesses called 911 about a two-car collision in the area of West Olympic Blvd. and Overland around 5:15 p.m., the Los Angeles Fire Department said in an incident alert.

A woman driving one of the vehicles was trapped in the wreckage and was deemed "beyond medical help," according to the department. She was pronounced dead at the

scene.

The driver of the other vehicle was a teenage boy, who was taken to an area hospital with moderate injuries.

A third vehicle was stopped near the scene of the crash but was not involved in the collision, the department said.

Aerial video showed two damaged vehicles, one of them appearing to be completely crushed.

Olympic was closed for 2 blocks in each direction for several hours, while the LAPD investigated the fatality collision.

# State Bar Sued Over Test Scans

A civil rights group has threatened to sue the California State Bar. The suit alleges that bar exam facial scans designed to identify test takers, are in fact just another example of systemic racism.

A prominent civil rights group is threatening to sue the State Bar of California unless it agrees to stop using facial recognition technology to prevent cheating on online bar exams, which the group says discriminates against women and people of color.

"It is by now well-established by experts in that field that FRT is disproportionately inaccurate in identifying women and people of color," the Lawyers' Committee for Civil Rights Under Law said in a Feb. 10 letter to California bar officials.

# FUNdraiser for Sandy Segal Youth Health Center




# Los Angeles Clippers vs. Miami Heat **Next Men Up**

Over the past couple of seasons, the Los Angeles Clippers have been touted as having the best bench players in the league, and so they did. The team won three sixth Man of the Year awards the past three years with Lou Williams and former Clipper Montrezl Harrell. Plus, Patrick Patterson, JaMycal Green, Shai Gilgeous-AlexanderGilgeous-Alexander, Maurice Harkless, and others have done an outstanding job coming off the bench over the past few years. Harrell, Green, Alexander and Harkless and some of the other players were all traded away, even coach Doc Rivers was fired last year after seven years with the team. So, talk of the best bench in the league belonging to the Clippers, was, well not so much this season. Well after watching lastMon-

of Marcus Morris Sr., Terance Mann, Serge Ibaka, Reggie Jackson and Lou Williams, all bench players except for Serge Ibaka. All of the starting reserves, except Reggie Jackson scored in double figures; in-fact six Clippers scored in double figures, and Lou Williams had a double-double, 18 points and 10 assists.


Lou Williams of the Clippers is stepping up in the absence of some of the starting players that that are missing games for the team. (Photo/Larry Salazar)

# Chargers and Rams set their sights on Super Bowl 56 at SoFi Stadium in 2022

With the Tampa Bay Buccaneers victory at Super Bowl 55 in Tampa, another successful NFL season is over and in the books. Next year's Super Bowl will be staged at SoFi Stadium in Inglewood, and in anticipation of this big event coming to Southern California,

line in the NFL in 2020. The Chargers averaged 3.8 yards per carry running the ball, which ranked 30th in the NFL in 2020. Herbert was sacked 32 times in 15 games and hit a lot more than that. the Los Angeles Chargers and the Los pressure, which he did often behind Angeles Rams are both in the process of upgrading their football teams to hopefully be participants in next year's Big Game.

This will be the first Super Bowl played in Southern California since January 26, 2003, when the Tampa Bay Buccaneers defeated the Oakland Raiders, 48-21at Qualcomm Stadium in San Diego, California. The last Super Bowl played in Los Angeles County was on January 31, 1993 at the Rose Bowl in Pasadena, when the Dallas Cowboys crushed the Buffalo Bills, 52-17.

The off-season coaching carousel and quarterback carousel has affected both franchises. The Chargers jumped onto the coaching carousel quickly, with the firing of head coach Anthony Lynn and the hiring of Rams defensive coordinator Brandon Staley as their new head coach. Staley has put together adiverse and impressive staff since his hiring.

The Chargers job was attractive because of Charger quarterback Justin Herbert, the NFL Offensive Rookie of the Year. Herbert is just 22 years of age (he turns 23 in March) and has a bright future ahead of him. If the offense was led by Tyrod Taylor, their starting quarterback in the first game last season the Chargers are just not that attractive. Herbert gives the Chargers a legitimate chance to win a Super Bowl, the only question being, how soon?

According to Pro Football Focus, the Chargers had the worst offensive


last season's offensive line.

Despite having the worst offensive line in the NFL, Herbert thrived in 2020. He was second in the NFL in deep touchdown passes with 12, the most ever produced by a rookie. PFF had a passing grade of 91.2 for Herbert on passes over20 yards, one of the better grades in the NFL. With a good offensive line, an improved defense and a little bit of luck, the Chargers could be in the Super Bowl next season.

But the Chargers need to stay healthy, particularly safety Derwin James, who has only played in five games the past two seasons, and they need better talent on the offensive line to become a legitimate Super Bowl contender. The Chargers go into the offseason with nine draft picks and according to Overcap.com they are currently \$24 million under the salary cap, which gives them some salary flexibility to sign free agents.

The Rams jumped onto the quarterback carousel, trading quarterback Jared Goff to the Detroit Lions for quarterback Matthew Stafford. The Rams also sent to the Lions a 2022 first round pick, a 2023 first round pick and a 2021 third round pick. Goff had struggled the past two seasons and his inability or unwillingness to throw deep had turned the Rams offense into a dink-and-dunk passing attack.

Stafford played 12 seasons with the Lions and played well but never was able to get his Lions teams past the first round of the playoffs. He only had one

# UCLA's Close Named Finalist for Naismith Coach of the Year

The Michael Price Family UCLA Women's Head Basketball Coach Cori Close has been named to the late season watch list for the Werner Ladder Naismith Women's Coach of the Year award, the Atlanta Tipoff Club announced Tuesday.

Close was one of 15 head coaches to be named a top-15 finalist for women's coach of the year recognition. She joined Arizona's Adia Barnes and Stanford's Tara VanDerveer among the Pac-12's honorees, as the Pac-12 tied for the most coaches on the list with the Big Ten and SEC.

Close has led the Bruins to a 12-3 verall record and 10-3 mark in Pac-12 play this season. It's the Bruins' sixthstraight season with at least 10 wins in Conference play. Among UCLA's victories this season are three wins against ranked opponents, including a road 73-71 victory over then-No. 7 Oregon that snapped the Ducks' 27-game winning-streak (Jan. 3). The win over Oregon also extended the Bruins' streak of defeating a top-10 opponent in each of the last six years. Close also led UCLA to a victory over then-No. 5 Stanford, knocking off the Cardinal, 70-66, in Santa Cruz, Calif.

Close, who is in her 10th year at the helm of UCLA's program, made history earlier in the season, as the Bruins' road victory against Arizona State (Dec. 9) marked her 200th-career win. She became only the third coach in program history to achieve the milestone, following Billie Moore (296-181)







# LAUSD Teams Up with the Los Angeles Rams and Hollywood Park to Offer a Vaccination Site For All School Staff in LA County

Los Angeles Unified today announced a collaboration with the Los Angeles Rams, Hollywood Park and the City of Inglewood to operate a large-scale vaccination site on the grounds of SoFi Stadium which could serve any of the public and private school teachers, administrators and staff in Los An-



geles County from schools that wish to participate.

Los Angeles Unified plans to work closely with Los Angeles County on this program. On February 15, Los Angeles Unified and its partners, including Anthem Blue Cross and Cedars-Sinai, sent a letter to County Department of Public Health Director Dr. Barbara Ferrer and Los Angeles County Office of Education Superintendent Dr. Debra Duardo seeking authorization to operate the site and help the more than 1 million students and tens of thousands of teachers and staff in Los Angeles County return to school safely.

"Returning students, teachers and staff to campus in the safest way possible is essential to the well-being of our entire community," said Los Angeles Unified Superintendent Austin Beutner. "A bus driver takes students to school, a principal unlocks the front door, a teacher leads in the classroom, a cafeteria worker prepares lunch and a custodian keeps the school clean – they're all connected at school. A dedicated vaccination site and comprehensive effort for the education community would allow schools to re-open sooner and in a more coordinated manner."

"In speaking with Superintendent Beutner and Inglewood Mayor Butts about how we can best support our community during this time, it became clear that assisting schools to reopen safely would have wide-ranging impacts for all Angelenos," said Los Angeles Rams COO Kevin Demoff. "We are grateful to all our partners who have come together to develop a game plan that would allow us to operate this vaccination site at Hollywood Park safely and efficiently and serve educators all across the county."

"We have seen a need within our community, and we are working along-side Los Angeles Unified and its partners to provide a solution," said Jason Gannon, managing director, SoFi Stadium and Hollywood Park. "We are proud to offer the space and infrastructure needed for a mass vaccination site for school staff. This is another critical step to keep Angelenos safe and healthy in our fight against COVID-19."

Inglewood Mayor James T. Butts has committed to seek the support of the

County Board of Supervisors for this effort to protect school staff and bring the children of Inglewood and Los Angeles County back to the classroom.

In accordance with its plan, 600 Los Angeles Unified school nurses and other licensed healthcare professionals would administer the vaccine and assist those who may have an adverse reaction. In addition, Anthem would provide volunteer clinical personnel to supplement the Los Angeles Unified staff and Cedars-Sinai is already providing training to support this vaccination effort. The Hollywood Park site, when fully operational, would be able to vaccinate more than 10,000 people a day

The operation would use a technology and data system that can register individuals, schedule vaccination appointments and share the data with appropriate authorities.

"Anthem Blue Cross is proud to support LAUSD's COVID-19 vaccination efforts and help ensure those who want to receive the vaccine can get it," said Beth Andersen, President, Anthem

Blue Cross.

"Safely reopening schools is a key step in improving our community's physical, mental and economic health," said Arthur J. Ochoa, JD, Chief Advancement Officer for Cedars-Sinai. "Cedars-Sinai has a long history of supporting Los Angeles Unified in its work to serve the children and families of Los Angeles and we are ready to support Los Angeles Unified in its effort to create a Super Point of Distribution so they can vaccinate school educators and staff."

"The fact is that schools never closed for thousands of frontline education workers who have been sanitizing schools, preparing meals and running COVID-19 testing centers," said Max Arias, SEIU Local 99 Executive Director. "Many of these essential school workers are people of color who have been hardest hit by the pandemic. The opening of this vaccination site would mark a major step forward to protect our most vulnerable communities and begin the process for an eventual safe return to in-person classes."




